

**COMMISSIONERS' PROCEEDINGS**  
**Week of July 30, 2001**

Commissioners Paul J. Kimmell, Loreca J. Stauber, and John A. (Jack) Nelson met in regular session on Monday, July 30, 2001, on Wednesday, August 1, 2001, and Friday, August 3, 2001; the following actions were taken:

Having held a public hearing as required by law, by Motion and Order, approved the Short Plat #618 as requested by Mark and Judy Comstock for a 10.51 acre parcel in the Rural Residential Zone, 5 acre minimum (R-5), and adopted the Findings of Fact and Conclusions of Law regarding the same.

Approved, signed and filed the Commissioners' Proceedings for the week of July 23, 2001.

Approved, signed and filed a request to hire Tausha M. Stapleton, Administrative Assistant, Youth Services, Department 08A, Line 02, effective July 23, 2001.

Approved, signed and filed a 2-year increment increase for John Simler, Permit Technician, Planning & Building, Department 11, Line 10, effective August 1, 2001.

Filed the resignation of Derik Rimel, Patrol Deputy, Sheriff, Department 04B, Line 13, effective August 9, 2001.

By Motion and Order, convened in Executive Session at 10:50 A.M. on July 30, 2001, to discuss "Personnel Matters," pursuant to Idaho Code Section 67-2345 (1)(a)&(b). Adjourned at 11:05 A.M.

By Motion and Order, rejected Steve Rishling's request for a tax cancellation for RPJ14200007520A.

By Motion and Order, approved the certification of 2001 and 2000 delinquent solid waste accounts (attached) to the 2001 tax bill. Each account will be billed \$4.00 for the certified mailing fee and \$5.00 in late fees for August through December.
