Approved, signed and filed the Commissioners' Proceedings for the Week of October 31, 2005.

Approved, signed and filed a Taxpayer's Adjustment for Charles Parker, MH21CT00006; cancellation due to mobile home being abandoned by Treasurer's Office in 2004 due to lack of sale.
