BRING PICTURE ID TO POLLS OR SIGNING OF PERSONAL IDENTIFICATION AFFIDAVIT WILL BE REQUIRED

MUST BE 18 YEARS OF AGE OR OLDER

MUST BE A RESIDENT OF THE COUNTY AND IN THE SCHOOL DISTRICT FOR AT LEAST 30 DAYS PRIOR TO THE ELECTION

**MUST BE A REGISTERED VOTER
ELECTION DAY REGISTRATION AT THE POLLING PLACES IS AVAILABLE
WITH PROPER VOTER IDENTIFICATION**

BRING PICTURE ID TO VOTE ON ELECTION DAY

**VOTERS WHO HAVE CHANGED THEIR NAME OR ADDRESS SINCE THE
PREVIOUS ELECTION ARE REQUIRED TO RE-REGISTER**
