MUST BE A U.S. CITIZEN

BRING PICTURE ID TO POLLS OR SIGNING OF PERSONAL IDENTIFICATION AFFIDAVIT WILL BE REQUIRED

MUST BE 18 YEARS OF AGE OR OLDER

MUST BE A RESIDENT OF THE COUNTY AND IN THE SCHOOL DISTRICT FOR AT LEAST 30 DAYS PRIOR TO THE ELECTION

MUST BE A REGISTERED VOTER

ELECTION DAY REGISTRATION AT THE POLLING PLACES IS AVAILABLE WITH PROPER VOTER IDENTIFICATION

VOTERS WHO HAVE CHANGED THEIR NAME OR ADDRESS SINCE THE PREVIOUS ELECTION ARE REQUIRED TO RE-REGISTER
