By Motion and Order, approved and signed a State of Idaho, Idaho State Police, Alcohol Beverage Control, Temporary Alcohol Beverage License Number 1932 for Dale Spring & Diana Senften dba Dale's Wagon Wheel Bar & Grille at 220 6<sup>th</sup> Street, Potlatch; effective through April 30, 2009.

Approved, signed and filed a Taxpayer's Adjustment on behalf of Rhonda Driskill, Parcel Number SM11CT00002BA; cancellation in the amount of \$250.30 as RV has moved.

Approved, signed and filed the transfer surplus equipment from surplus to ITS.

By Motion and Order, reversed and modified the decision of December 8, 2008 in regards to a Request for Taxpayer's Adjustment by Mark & Barbara Yochum, Parcel Number RP016200000020A. The Board shall approve that 2008 taxes be calculated on the more accurate 2009 total assessed value of \$111,946, from the 2008 total assessed value of \$153,091 for a difference of \$41,145 in value. The recalculated 2008 taxes in the amount of \$1,354.84 plus the forest protection fee for a total tax bill in the amount of \$1,371.08, of which \$413.28 remains due for the first half of 2008 tax bill. Penalty and interest will be waived if this amount is paid on or before March 25, 2009. Further, the second half of 2008 taxes will be due on or before June 20, 2009 in the amount of \$685.54. Total tax reduction in the amount of \$497.92. Said decision based on meeting with the taxpayer and upon recommendation of the Assessor.
