Commissioners John A. "Jack" Nelson and Jennifer Barrett met in regular session on Monday, July 27, 2009 the following actions were taken:

Approved, signed and filed a request to surplus equipment – Parks and Recreation: dispose of one item as has no value, rest go to surplus.

By Motion and Order, approved and signed Agreement between Clints & Lam Auctioneers and Latah County; County agrees to pay Auctioneer twenty-five per cent (25%) of gross proceeds; Auctioneers will provide itemized listing of items sold together with final accounting and payment; auction will be held at the Latah County Fairgrounds Building (1021 Harold Street, Moscow, Idaho) on Sunday, August 9, 2009; effective July 27, 2009.

Signed and filed Certificate of Completion for the Roofing Project at 1021 Harold Street (Latah County Fairgrounds).
