

COMMISSIONERS' PROCEEDINGS
Week of July 30, 2012

Commissioners Jennifer Barrett, Tom S. Stroschein, and David McGraw met in regular session on Monday, July 30, 2012 and again on Wednesday, August 1, 2012 the following actions were taken:

By Motion and Order, approved the consent calendar items as published on the agenda:

- Files Separation From Employment for Kiley Cobb, Law Clerk of the Court, Clerk of the Court, Department 01AA, Line 01, effective August 10, 2012.
- Approval to hire Michael Kirkham, Law Clerk of the Court, Clerk of the Court, Department 01AA, Line 01, effective August 13, 2012.
- Filed fully executed Lease agreement between Latah County Sheriff's Office and City of Genesee for the Genesee repeater site.
- Filed letter dated July 24, 2012 from City of Bovill regarding solid waste disposal and collections contracts.
- Filed letter dated July 26, 2012 from City of Troy regarding solid waste disposal and collections contracts.

Approved, signed and filed a Taxpayer's Adjustments on behalf of John Dunn, Parcel Number RP39N04W214814A; cancellation of main roll taxes and will be assessed without Homeowner Exemption on 2012 Subroll.
