**Route Driven:** Main Parking lot of Latah County Courthouse – North on Van Buren to 3<sup>rd</sup> Street; West on 3<sup>rd</sup> to Hwy 95; North on Hwy 95 to E St.; West on E to Almon; North on Almon/Mix to Canterwood Dr; West on Canterwood Dr; Turnaround; East on Canterwood Dr to Mix; North on Mix to Hwy 95; South on Hwy 95 to Foothill; West on Foothill to Idlers Rest; North on Idlers Rest to Corner of Shultz/Idler's Rest; Turnaround; South on Idler's Rest to Foothill; North on Foothill to Lewis; West on Lewis to Nearing; North on Nearing to Saddle Ridge Rd; North on Saddle Ridge to Fourmile; West on Fourmile to Hwy 95; South on Hwy 95 to Viola Rd; West on Viola Rd to Cemetery; Turnaround; East on Viola Rd to Hwy 95; North on Hwy 95 to Dales Hardware/Junction Lumber; North on Hwy 95 to Freeze Rd; East on Freeze Rd to D8; Turnaround; West on Freeze Rd. to Hwy 95; South on 95 to Hwy 6; East on Hwy 6 to Hwy 9; South on Hwy 9 to N Avon Road; North on N Avon Road to Rue loop Road; Turn around; South on N Avon Road to Hwy 9; South on Hwy 9 to Hwy 8; East on Hwy 8 to McKeehan Rd; West on McKeehan Rd to Hwy 8; West on Hwy 8 to Wallen Rd.; North (then West) on Wallen Rd to Robinson Park Rd.; West on Robinson Park Rd. to Joseph; West on Joseph to Mountainview Rd; North on Mountainview Rd to 6<sup>th</sup>; West on 6<sup>th</sup> to Van Buren; North on VanBuren to Courthouse Parking lot.


